I further understand that, although the ski-binding-boot system may reduce the risk of certain injuries to the lower leg, it likely **CANNOT PROTECT THE KNEE** or any other part of the skier's body.
6. I have received instructions in the use of this equipment and have received satisfactory answers to any questions I may have regarding the use and function of this equipment. If I feel that the equipment is not functioning properly, I will stop using it and have it inspected or readjusted by a ski-binding technician.

To the fullest extent of the law, I hereby release, indemnify and hold harmless the ski shop and all manufactures and distributors of this equipment, and their owners, agents, and employees, from any and all liability for damage to myself or to any other person or property which may result while using this equipment, and waive any right to present any legal claim or suit against these persons, whether based upon negligence, breach of warranty, strict product liability or other legal theories.
